**Ordinance No. 2018-003**

AN ORDINANCE OF THE BOROUGH OF UNION DALE, SUSQUEHANNA COUNTY, COMMONWEALTH OF PENNSYLVANIA, PROVIDING FOR QUARTERLY SALARY PAYMENTS FOR THE MAYOR AND MEMBERS OF BOROUGH COUNCIL OF THE BOROUGH OF UNION DALE INSTEAD OF MONTHLY SALARY PAYMENTS, ELIMINATING THE REQUIREMENT THAT THE MAYOR AND/OR ANY COUNCIL MEMBER ATTEND ANY SPECIFIC MEETING TO COLLECT HIS OR HER SALARY, REPEALING ALL ORDINANCES INCONSISTENT HERewith, INCLUDING ORDINANCE NO. 2016-001, AND ESTABLISHING AN EFFECTIVE DATE.

**WHEREAS**, Council of the Borough of Union Dale is empowered with the authority to enact ordinances fixing the compensation of all borough officers, appointees and employees, pursuant to the limitations set forth in the Borough Code; and

**WHEREAS**, the salary of the Mayor and Members of the Borough Council of the Borough of Union Dale are paid in monthly installments and contingent on attendance at one (1) monthly meeting; and

**WHEREAS**, §1001(e) of the Borough Code, 8 Pa. C.S.A. §1001(e), provides that members of council of a borough having a population of less than five thousand (5,000) residents may be compensated in an amount not to exceed \$1,875.00, per year; and

**WHEREAS**, Section 10A04(a) of the Borough Code, 8 Pa. C.S.A. §10A04(a), provides that the mayor of a borough having a population of less than five thousand (5,000) residents may be compensated in an amount not to exceed \$2,500.00, per year; and

**WHEREAS**, the population of the Borough of Union Dale is 267, pursuant to the 2010 United States census; and

**WHEREAS**, the Council of the Borough of Union Dale, having considered and studied the burden on payment of salaries on a monthly basis, has concluded that salaries should be paid on a quarterly basis as set forth in detail below; and


**WHEREAS**, the Borough Code does not require attendance at any meeting to entitle the Mayor and/or and Members of the Borough Council of the Borough of Union Dale to be present at any meeting to receive his or her compensation.


**NOW THEREFORE**, the Council of the Borough of Union Dale, Susquehanna County, Commonwealth of Pennsylvania, hereby enacts and ordains as follows:


1. The Mayor of the Borough of Union Dale shall receive compensation in the amount of Three Hundred and Sixty Dollars (\$360.00) per year, to be paid in quarterly installments.
2. Each Member of the Council of the Borough of Union Dale shall receive compensation in the amount of Three Hundred and Sixty Dollars (\$360.00), per year, to be paid in quarterly installments, provided however that Members elected prior to the increase in salary, effective November 14, 2016, shall continue to receive Three Hundred Dollars (\$300.00) per year payable in quarterly installments, until the next term of that Member, at which time all Members of the Council of the Borough of Union Dale shall receive compensation in the amount of Three Hundred and Sixty Dollars (\$360.00), per year, to be paid in quarterly installments.
3. No insurance and/or other benefit will be provided to the Mayor and/or any member of the Council of the Borough of Union Dale.
4. This Ordinance shall repeal all Ordinances inconsistent herewith, including, but not limited to, Ordinance No. 2016-001.
5. This Ordinance shall become effective immediately upon enactment.
