RESOLUTION INDICATING ACCEPTANCE AND SUBMISSION OF AN OFFICIAL PLAN FOR SEWAGE FACILITIES IN THE BOROUGH OF NEW MILFORD, SUSQUEHANNA COUNTY, PENNSYLVANIA

WHEREAS Section 5 of the Pennsylvania Sewage Facilities Act, Act of January 24, 1966, P.L. 1535, requires that each municipality shall submit for approval to the Pennsylvania Department of Health an officially adopted plan for sewage facilities serving areas within its jurisdiction, the Borough Council of New Milford Borough, Susquehanna County, Pennsylvania hereby resolves that the attached plan, submitted this 7th day of January, 1971, is accepted as its Official Plan for the orderly development of sewage facilities within its jurisdiction.

Adopted on the 7th day of January, 1971, and included in the Minutes of a Regular meeting of Borough Council of New Milford, Susquehanna County, Pennsylvania.

NEW MILFORD BOROUGH SEWER PLAN

EXISTING SYSTEM

There are no public sewer facilities in New Milford Borough.

SOIL EVALUATION

Soils in most parts of the Borough possess "slight" limitations for on-site disposal systems.

POPULATION

The population of the Borough in 1960 was 1,129. Projections made by the Northern Tier Regional Planning and Development Commission indicate that its present population is 1,080 and by 1980 it may increase to 1,288.

SEWER PLAN - 1970 - 1980

Since the majority of the soils within the Borough have "slight" limitations, it is recommended that on-lot disposal be continued to by the method of sewage treatment. This presumes that any future development will have adequately designed systems. The installation of these systems should comply with the requirements of Act 537.

SUGGESTED MUNICIPAL RESOLUTION AREAWIDE PLANNING AGENCY DESIGNATION

WHEREAS, THE Borough of New Milford recognizes that the Northern Tier Regional Planning and Development Commission is responsible for preparing an overall plan of development for the many phases of community activity in the Northern Tier Counties of Bradford, Sullivan, Susquehanna, Tioga and Wyoming;;and

WHEREAS, the Borough of New Milford recognizes the need for municipal planning and coordination of municipal planning within the Northern Tier region; and

WHEREAS, the Borough of New Milford from time to time has participated with the Northern Tier Regional Planning and Development Commission in preparation of community-wide plans and local planning projects; and

WHEREAS, the Borough of New Milford desires to insure a continuance of areawide planning with increased involvement of local officials.

WHEREAS, THEREFORE, BE IT RESOLVED THIS 5th DAY OF MARCH, 1970 BY THE COUNCIL OF NEW MILFORD BOROUGH THAT:

1. The Council is aware of the role of the Northern Tier Regional Planning and Development Commission in developing are-wide planning programs, tha t help to interrelate and coordinate planning of individual municipalities; and
2. The Council recognizes that the Northern Tier Regional Planning and Development Commission is the representative agency to continue are-wide planning for this and adjoining municipalities, to perform planning in the Northern Tier Area and to act as the area-wide review agency.
