## ORDINANCE #461 BRAKE RETARDER ORDINANCE

AN ORDINANCE OF THE BOROUGH OF SUSQUEHANNA DEPOT, SUSQUEHANNA COUNTY PENNSYLVANIA, DECLARING THE OPERATION OF A BRAKE RETARDER INSTALLED UPON OR IN A GASOLINE POWERED OR DIESEL POWERED MOTOR VEHICLE NOT EQUIPPED WITH EXHAUST MUFFLERS OR EQUIPPED WITH INOPERABLE OR MODIFIED EXHAUST MUFFLERS SO AS TO PERMIT THE CREATION OF EXCESSIVE NOISE THROUGH THE EMPLOYMENT OF SAID BRAKE RETARDER TO BE A NUISANCE IN FACT; ESTABLISHING EXCEPTIONS TO THE ENFORCEMENT OF SAID ORDINANCE IN EMERGENCY SITUATIONS.

Section 1: This ordinance shall be known as the Borough of Susquehanna Depot Brake Retarder Ordinance.

Section 2: The Borough Council of the Borough of Susquehanna Depot, Susquehanna County, Pennsylvania, finds as a fact that the operation of a brake retarder on a gasoline powered or diesel powered motor vehicle not equipped with exhaust mufflers, or equipped with defective or modified exhaust mufflers, so as to create excessive noise through the use of said brake retarder, adversely affects the public health, safety and welfare of the residents of W. Main Street, bound from Oakland Township/Susquehanna Depot Borough line, to the intersection of Third Avenue and W. Main Street in the Borough of Susquehanna Depot.

Section 3: No gasoline powered or diesel powered motor vehicle shall be operated on W. Main Street from the Oakland Township/Susquehanna Depot line, in the east bound direction on W. Main Street to the Third Avenue intersection with W. Main Street utilizing, in said operation, a brake retarder, without exhaust mufflers, or with defective or modified exhaust mufflers permitting excessive noise to be created by said motor vehicle.

Section 4: This ordinance shall not apply to emergency driving situations requiring the utilization of a brake retarder to protect the safety and property of the residents of W. Main Street, from Oakland Township/Susquehanna Depot Borough line, east bound to Third Avenue intersection with W. Main Street and Third Avenue, other motor vehicle operators, pedestrians, and the operator and passengers of the motor vehicle involved in said emergency situation.

Section 5: Any person, firm, corporation or organization violating any of the provisions of this ordinance shall, upon summary conviction before a District Magistrate having jurisdiction, be sentenced to pay a fine of no more than Three Hundred (\$300.00) Dollars and costs of prosecution, and in default of the payment thereof, shall be sentenced to undergo imprisonment in the Susquehanna County Jail for a period not to exceed ten (10) days.

Section 6: This ordinance shall become effective after its adoption and upon placement of required signs.

<u>Section 7:</u> The provisions of this ordinance shall be severable and if any of its provisions shall be held to be unconstitutional, illegal or invalid, or otherwise unenforceable by a Court of competent jurisdiction, the remaining portions hereof shall not be affected thereby.

Section 8: Any ordinance or part of an ordinance conflicting with the terms of this ordinance is hereby specifically repealed.

THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY UPON ITS PASSAGE AND APPROVAL AND PLACEMENT OF REQUIRED SIGNAGE.
