## ORDINANCE NO.

215 1/5

Regulating traffic generally and in certain streets particularly.

The Borough of Susquehanna Depot hereby ordains:

1. On or after the passage and approval of this Ordinance it shall be unlawful for any person, firm or corporation to park any motor or other vehicle on any of the following streets or sections of streets:

North Side of West Main Street

North Side of Washington Street

North Side of Prospect Street

West Main between First and Second Avenues

Franklin Avenue between Main and Washington Streets

West Side of Franklin Avenue--Washington Street to Borough Line.

North Side of Vine Street

Depot Street

North Side of Front Street from Depot Street to Borough Line

Frie Avenue -- 300 feet South of Main Street

West Side of Erie Avenue to Borough Line

Euclid Avenue

South side of East Main Street

North side of East Main Street from Willow Avenue to Borough Line

West side of Willow Avenue

West side of West Church Street

South side of East Church Street

South Side of Grand Street from

Willow Avenue to Jackson Avenue

North Side of Grand Street from Jackson Avenue to Broad Avenue

South Side of Grand Street from Broad Avenue to Borough line

South side of Elm Street

South side of Pine Street

South side of Oak Street

Broad Avenue--East Main Street to Church Street

Broad Avenue from Church Street to Turnpike on South or West side

Pleasant Avenue west side

Turnpike Street west side

North side of Myrtle Street

Laurel Street south side

Columbus Avenue west side

Jackson Avenue west side

- 2. No motor or other vehicle shall be parked:
  - (a) Within any intersection.
  - (b) On a crosswalk.
  - (c) Within fifteen feet from the intersection of curb lines.
  - (d) Within fifteen feet of a fire hydrant.
  - (e) On a sidewalk.
- 3. It shall be unlawful for the operator of any vehicle to park said vehicle on any street for a period of time longer than thirty minutes between the hours of 2 a.m., and 6 a.m. of any day.
- 4. Except when necessary in obedience to traffic regulations or traffic signs or signals, the operator of a vehicle shall not stop, stand, or park such vehicle in a roadway other than parallel with the edge of the roadway, headed in the direction of traffic, and with the curb side wheels of the vehicle within six inches of the edge of the roadway, except on those streets which have been marked for angle parking.
- 5. Vehicles travelling on the following streets in the following directions shall come to a full and complete stop, before proceeding into or through the following intersections:

Washington Street East and West at Third Avenue Washington Street East and West at First Avenue Washington Street East and West at Fifth Avenue Washington Street East and West at Sixth Avenue Washington Street East or West at Fourth Avenue Washington Street East or West at Second Avenue East at Intersection of Franklin Avenue Depot Street East at Intersection of Main Street Prospect Street East or West at First Avenue Prospect Street East at Franklin Avenue Vine Street East at Franklin Avenue High Street East at Franklin Avenue East Street East at Franklin Avenue TErie Avenue North at Main Street Willow Avenue North at East Main Street Broad Avenue North at East Main Street Spring Avenue North at East Main Street East Church Street East at East Main Street Church Street East or West at Broad Avenue Broad Avenue North or South at Grand Street Grand Street East or West at Broad Avenue Jackson Avenue North or South at Grand Street

6. Whenever a vehicle is stopped or parked on a street except those streets within the boundary of the Main Street business section, during the times between one half hour after sunset and one half hour before sunrise, said vehicle shall have displayed upon it a parking light which shall be discernible for a distance of at least two hundred feet.

Laurel Street West at Jackson Avenue

- 7. No motor or other vehicle shall be operated at a speed in excess of 25 miles per hour, on any of the streets within the Borough Limits of the Borough of Susquehanna Depot.
- 8. Traffic moving West on Main Street, shall be allowed to make a right hand turn into Exchange Street, after coming to a full and complete stop, while the Traffic Light at the inter-

- 9. The Chief of Police or special officers under direction of the Burgess, are hereby empowered to make and enforce regulations necessary to make effective the provisions of this ordinance and to make and enforce temporary regulations to cover emergencies or special conditions.
- 10. Any person violating any of the provisions of this Ordinance shall pay a fine of not less than Two Dollars nor more than Ten Dollars to be recovered for the use of the said Borough as fines of like amount are now recoverable and in default of the payment of said fine shall be committed to the Borough lock-up for a period of not less than forty-eight hours.
- ll. All ordinances or parts of ordinances in conflict with or inconsistent with the provisions of this Ordinance are hereby repealed.
