

ORDINANCE #489 OF 2012

FOREST CITY BOROUGH

AMENDING AND MODIFYING ORDINANCE #475 of 2008 BY ESTABLISHING A SEWER SERVICE FEE SCHEDULE

WHEREAS, Forest City Borough (the "Borough"), in order to replace the existing sewer collection system for rendering sewer collection service in the Borough, has undertaken a project involving the design, acquisition, and construction of a new sewer collection system; and

WHEREAS, it has been determined that the Borough must establish and collect service fees in order to meet the anticipated administrative and operational costs of said sewer system; and

WHEREAS, the Borough has determined it is in the best interest of the citizens of said Borough to collect all related sewer fees and charges collected pursuant to Ordinance No: 475 of 2008 in house; and


WHEREAS, Section 2.05 of Ordinance #475 of 2008 allows for the review and adjustment of all sewer related fees and charges;

NOW, THEREFORE, BE IT ENACTED BY THE BOROUGH OF FOREST CITY as follows:

1. The sewer related charges in Ordinance 475 of 2008 shall be and are hereby amended as shown on Exhibit A: Sewer Connection Fees, User Fees and Service Fees, attached hereto and by this reference incorporated herein. (Available at Borough Secretary's Office.)
2. Section 4.01 "Time and Method of Payment" of Ordinance 475 of 2008 shall be and is hereby amended to state the User Fees shall be billed and collected monthly and not quarterly.


3. Section 4.02 "Billings" of Ordinance 475 of 2008 shall be and is hereby amended as shown on Exhibit A: Sewer Connection Fees, User Fees and Service Fees, attached hereto and by this reference incorporated herein. (Available at Borough Secretary's Office.)
4. Except as modified and amended hereby, Ordinance No. 475 of 2008 shall in all other respects remain in full force and effect.
5. Exhibit A: Sewer Connection Fees, User Fees and Service Fees may be amended from time to time by resolution of the Council of the Borough, as appropriate.
6. That this Ordinance and the amendments and modifications hereby made, shall become effective 30 days from the date of its enactment and prior thereto shall be posted and published as required by law.
