Ordinance 2013-03

**AN ORDINANCE TO AMMEND BY REMOVING THE FINES AND FEES FROM
THE LISTED ORDINANCES.**

WHEREAS, the Borough Council of the Hop Bottom Borough, Susquehanna County, Pennsylvania, has voted to amend by removing the fines and fees from the listed Ordinances:

NOW, THEREFORE, the Council of Hop Bottom, Susquehanna County, Pennsylvania, does hereby ordain and enact the following amendment:

The following fines and fees will be removed from the following Ordinances.

1949-02 Sidewalk Ordinance

Section V – (Repairs) No dollar amount is given.

Section VI – (Snow) No dollar amount is given.

1960-02 Dog Ordinance (Running loose)

Fine of \$10 and the costs of prosecution or up to 5 days in jail

1973-02 Junk-Salvage Ordinance

Section 3 – fine of not less than \$25 nor more than \$200 and the costs of prosecution for each violation. A few and separate offense for each day that said violation exists.

Section 4 – “Continued violations... shall constitute a nuisance....”

1979-02 Street Openings Ordinance

Section 4 – Permit fee minimum amount of \$25 plus \$50 per 100 feet

Section 5 – if repair work defective after 2 years.... Applicant shall reimburse Borough for cost of repairs...

Section 6 – If repair work done by Borough applicant will be charged actual cost plus 20%

Section 7 (i) – Borough to correct unsatisfactory work – charged actual cost plus 20% to applicant

Section 8 –Emergency repairs made – charged at cost plus 20%

Section 12 – violators upon conviction pay no less than a \$100 fine plus cost of prosecution and imprisoned for not more than 30 days.

1980-02 Zoning Ordinance

Section 6.8 – Violations

fine of not more than \$500 plus the costs of prosecution for each and every offense or not more than 60 days imprisonment or both.

Section 6.9 – Fees

Zoning Permit - \$15

Variance or Appeal Application \$25

Request for Amendment \$50

Certificates of Nonconformance \$5

Application for Interpretation of Boundaries \$10

1983-03 Earned Income Tax Ordinance

½%

Article 7 – Interest and Penalties – 6% annum interest plus penalty of ½%

Article 8 – Fines and Penalties – not more than \$100 and costs of prosecution for each offense or not more than 30 days in County Jail

1992-03 Zoning Permit Fee Schedule

Zoning Permit Fee \$5

Variance or Exception (Requiring action by Board) \$175

Removal all Building Permit Fees

(All Building Permit Fees are through COG)

1992-04 Peddling Ordinance

Section III – One year Permit fee \$300 or one day fee of \$100

Section IV – Fine of \$500 and costs of prosecution or not more than 30 days in jail.

1992-05 Dog Ordinance

Section II - \$300 fine plus costs of prosecution and any costs of restitution for property damage or not more than 30 days in jail. (In addition to the PA State Code)\

1992-08 Discharge of Firearms Ordinance

Section II – fine of not less than \$100 nor more than \$300 or imprisonment for not more than 30 days or both.

1993-02 Nuisances & Disturbances of the Peace

Part I (littering) *B Penalties* - \$25 for first offense upon conviction \$50 for second offense & \$100 for third and all subsequent offenses

Part II (alcohol) *D Fines & Penalty* - \$25 for first offense upon conviction \$50 for second offense & \$100 for third and all subsequent offenses together with the costs of prosecution for each offense

1993-03 Burning Ordinance

Section II – burning materials not permitted: fine of no less than \$25 or not more than \$300

Section III – burning a field without prior arrangements with Fire Company: fine of no less than \$25 or not more than \$300

1994-04 Curfew for Minors

Section 8 – Penalties: (after 3rd offense) fine of not less than \$25 or not more than \$300 or imprisonment for not more than 30 days.

1995-03 Dangerous Buildings

Section VI – Penalties

A: *failure to comply* - upon conviction fine not exceeding \$300 and costs (30 days in jail) Each day = new offense. Penalties are in addition to any other remedies provided

B: *removing notice* – upon conviction fine not exceeding \$50 and costs (10 days in jail)

C: *council taking action* – owner pay costs plus penalty of 10% (may include A&B)

Section VIII – Fire Escrow Law

B. (1) \$1,000 for each \$20,000 of a claim

C. may by resolution adopt... reasonable fees to be charged....

D. penalty of up to \$1000 per violation (Fire Escrow Law)

1995-04 Animal Ordinance

Section IV – fine of not less than \$50 or more than \$100 plus costs of prosecution. Separate offense for each day violation occurs or continues

1998-05 Prohibiting Nuisance Acts

Section III – amount of fine and term of imprisonment vary depending on severity and prior convictions – in no case shall the fine be less than \$50. In any situation where the law of a higher authority shall impose a greater sentence as to the fine and/or imprisonment the greater sentence shall be given

2004-02 Assessment Permit Ordinance (less than 500sq.ft.)

Section 2.3 fees – “fee schedule will be attached resolution...”

Section 3.0 Penalties: upon conviction not less than \$25 nor more than \$300 plus costs of prosecution.

2004-06 Assessment Permit Ordinance (less than 1000 sq.ft.)

Section 2.3 fees – “fee schedule will be attached resolution...”

Section 3.0 Penalties: upon conviction not less than \$25 nor more than \$300 plus costs of prosecution.

2005-03 Snow Emergency Routes & Parking

Section 2 e – upon conviction fine not to exceed \$300 each day = separate offense

2007-12 International Property Maintenance Code (2006)

Section 2 (section 103.5)

2011-03 Vehicles & Traffic Ordinance

Section 3 (Signs) C. Full restitution for damaged signs plus \$100.

Section 10. (Violations & penalties) – Per PA motor vehicle code.

2011-04 Snow Emergency Routes & Parking


Section 2 E. \$300 fine upon conviction for any violation of this section. Each day = separate offense.

Section 3 F. Fine of not more than \$300 together with the costs of prosecution and costs for towing and storage of vehicle.




