

ORDINANCE NO. 94-3

AN ORDINANCE OF THE BOROUGH OF HOP BOTTOM PROVIDING FOR APPOINTMENT OF AN INDEPENDENT AUDITOR AND FOR THE COMPENSATION THEREOF; ABOLISHING THE OFFICE OF ELECTED AUDITOR BUT PROVIDING FOR THEIR CONTINUATION IN OFFICE UNTIL THE END OF THEIR TERMS AND THE SETTLEMENT OF CURRENT ACCOUNTS.

The Council of the Borough of Hop Bottom hereby ordains:

Section 1. Appointment. The Council of the Borough of Hop Bottom shall, by resolution adopted annually before the commencement of a fiscal year, appoint an independent auditor who shall be a certified public accountant, registered in Pennsylvania, a firm of certified public accountants so registered or a competent public accountant or a competent firm of public accountants to audit, for such fiscal year, the accounts, records and all other evidences of financial transactions of the Borough of Hop Bottom and file a report thereof with the Council. The independent auditor shall perform all other duties and exercise such powers as required of, or conferred upon him, by law.

Section 2. Office Abolished. Upon appointment of an independent auditor as provided for in section 1 of this ordinance, the office of elected auditor is hereby abolished; however, the elected auditors now in office shall continue to hold such office for the term for which elected, and shall perform the duties of their office, except that they shall not audit, settle, or adjust accounts audited by such independent auditor.

Section 3. Compensation. The resolution appointing an independent auditor shall state the compensation, if any, to be paid from the Borough of Hop Bottom funds for said services.

Section 4. Right to Abolish Office Reserved. The Council of the Borough of Hop Bottom hereby reserves the right at any time to repeal this ordinance, thereupon abolishing the office of appointed auditor, and to reestablish the office of elected auditor.

Section 5. Repealer. All ordinances or parts of ordinances which are inconsistent herewith are hereby repealed. The following ordinances or parts thereof are specifically repealed:

RESOLUTION NO. 94-5

THIS RESOLUTION, approved and adopted by the members of the Hop Bottom Borough Council, Susquehanna County, Pennsylvania, on the date hereinafter set forth.

WITNESSETH:

WHEREAS, Section 7503 of the Pennsylvania Emergency Management Services Code, 35 Pa. C.S.A. Section 7101 et. seq. mandates that Hop Bottom Borough prepare, maintain and keep current a emergency operations plan for the prevention and minimization of injury and damage caused by a major emergency or disaster within this Borough; and

WHEREAS, in response to the mandate stated above, this Borough has prepared an emergency operations plan to provide prompt and effective emergency response procedures to be followed in the event of a major emergency or disaster; and

WHEREAS, this Borough has also prepared an emergency operations plan in order to reduce the potential affects of a major emergency or disaster and to protect the health, safety and welfare of the residents of this Borough;

NOW THEREFORE, we, the undersigned members of the Hop Bottom Borough Council do hereby approve, adopt and place into immediate effect the Emergency Operations Plan of Hop Bottom Borough. This Plan shall be reviewed on an annual basis to make certain that it conforms with the requirements of the Susquehanna County Emergency Operations Plan.
