

**ORDINANCE NO. 19**  
**SUPERVISOR COMPENSATION**  
(Per Meeting basis)

The following ordinance is hereby adopted by the Board of Supervisors of Liberty Township, Susquehanna County.

WHEREAS, the General Assembly of the Commonwealth of Pennsylvania has enacted Act 60 of 1995, setting forth certain guidelines and limitations for the compensation of supervisors of townships of the second class, and

WHEREAS, said act provides that supervisors of townships having a population of not more than 4999 may be compensated in an amount not to exceed \$1,875.00 per year, and

WHEREAS, the population of Liberty Township is 1353, and

WHEREAS, the General Assembly of said Act 60 authorizes the board of supervisors of the various townships of the second class to determine the compensation of supervisors subject to the limitations set for them in the act,

Now, therefore it is hereby enacted and ordained as follows:

1. Each supervisor of Liberty Township elected or appointed to office on or after the effective date of this ordinance shall receive compensation for attending duly advertised general or special public meetings or hearings of the board of supervisors, or other meetings authorized by the board of supervisors at the rate of \$100.00 for each meeting attended by each supervisor, not to exceed \$1,875.00 per year.

2. Such compensation shall be paid in monthly or quarterly installments.

3. This ordinance shall become effective on January 1, 1999.

The effective date of this Ordinance No. 19 shall be January 1, 1999, and shall remain in force until modified, amended or rescinded by the Township of Liberty, Susquehanna County, Pennsylvania.


