BOROUGH OF SUSQUEHANNA DEPOT SUSQUEHANNA COUNTY, PENNSYLVANIA

Ordinance #444

An Ordinance of the Borough of Susquehanna Depot, Susquehanna County, Pennsylvania amending Ordinance #434 adopting the Uniform Construction Code.

Whereas on June 23, 2004 the Borough of Susquehanna Depot adopted Ordinance #434 regarding Administration and Enforcement of the provisions of the Pennsylvania Construction Code Act and by reference adopting the International Code Council Codes; and

Whereas it is necessary to revise certain sections of said International Code Council Codes to provide specific local information and specifications; and

Now therefore it is hereby enacted and ordained as follows:

- 1. This Municipality hereby amends all the appropriate sections of said International Codes to designate the name of the jurisdiction as Borough of Susquehanna Depot.
- 2. The Borough of Susquehanna Depot hereby amends the appropriate sections of said 2006 International Codes to insert the fee schedules and fines promulgated or to be promulgated and adopted by resolution of the Borough.
- 3. The Borough hereby amends the 2006 International Plumbing Code Section 106.6.3 to insert the following figures: 100% 1%; Section 305.6.1 to insert 36"; Section 904.1 to insert 6", Sections 108.4 and 108.5 to insert the words ordinance and police.
- 4. The Borough hereby amends the 2006 International Residential Code Section P2603.6.1 to insert 36"; Section P3103.1 to insert 6" and Table R301.2 (1) in accordance with the attached Climatic and Geographic Design criteria.
- 5. The Borough hereby amends the 2006 International Building Code Section 1612.3 to insert Flood Map adopted November, 1971 and Section 3410.2 to insert the following date: April 7, 2004.
- 6. The Borough hereby amends the 2006 International Mechanical Code Section 106.5.2 to insert the fee schedules promulgated and to be promulgated and adopted by resolution of the Borough; Section 106.5.3 to insert the following percentages: 100% 1%; Section 108. 4 to insert the following: fines previously or to be promulgated and adopted by Borough resolution

add the words ordinance, and police, Section 108.5 fines previously or to be promulgated and adopted by resolution, ordinance and police.

- 7. The Borough hereby amends the 2006 International Property Maintenance Code Section 103.5 to provide fee schedule previously or to be promulgated and adopted by resolution of the Borough, Section 304.14 to insert dates April 1st to October 1st for screens, Section 602.3 to insert dates October 1st to April 1st for heat, Section 602.4 to insert dates October 1st to April 1st for commercial heat.
- 8. The Borough hereby amends the 2006 International Existing Building Code Section 1301.2 to insert the date April 9, 2004.
- 9. The Borough hereby amends the 2006 International Mechanical Code Section 106.5.3 to insert the following: 100%-1%. Amends Section 108.4 and 108.5 to insert the words ordinance and police.
