

TAX ORDINANCE

AN ORDINANCE of the Township of Middletown, Susquehanna County, Commonwealth of Pennsylvania, fixing the tax rate for the fiscal year 1993.

BE IT ORDAINED AND ENACTED, and it is hereby ordained and enacted by the Supervisors of Middletown Township, Commonwealth of Pennsylvania:

SECTION 1. That a tax be and the same is hereby levied on all property and occupations within the said Township subject to Taxation for Township purposes for the fiscal year 1993, as follows:

Tax rate for general Township purposes, the sum of ten (10) mills on each dollar of assessed valuation;

Making a total for all Township purposes of ten (10) mills.

SECTION 2. That any ordinance, or part of ordinance conflicting with this ordinance be and the same is hereby repealed insofar as the same affects this ordinance.

ORDINANCE

AN ORDINANCE PROVIDING FOR THE LEVY, ASSESSMENT AND COLLECTION OF AN OCCUPATION TAX, FOR GENERAL TOWNSHIP PURPOSES, UNDER THE AUTHORITY OF THE LOCAL TAX ENABLING ACT OF THE THIRTY FIRST DAY OF DECEMBER 1965 AND ITS AMENDMENTS, ON EACH AND EVERY RESIDENT AND INHABITANT OF THE TOWNSHIP OF MIDDLETOWN OVER TWENTY-ONE (21) YEARS OF AGE, PROVIDING FOR THE COLLECTION OF SUCH TAX BY THE TOWNSHIP TAX COLLECTOR, IN ACCORDANCE WITH THE LOCAL TAX COLLECTION LAW OF 1945 AS AMENDED AND SUPPLEMENTED AND THE LOCAL TAX ENABLING ACT AND SUBJECT TO THE PENALTIES PRESCRIBED THEREIN.

The Township Hereby ordains as follows, under the authority of the Local Tax Enabling Act of December 31st, 1965 and its amendments:

Section 1. An occupation tax of \$10.00 for general Township purposes, is hereby levied and assessed under the authority of the Local Tax Enabling Act and its amendments, upon each resident or inhabitants of the Township of Middletown, over the age of twenty-one (21) years, which tax shall be in addition to all other taxes levied and assessed by the said Township pursuant to any other laws of the Commonwealth of Pennsylvania.

Section 2. Such tax shall be collected by the duly elected or appointed tax collector of the Township of Middletown in the same manner and at the same time as other Township Taxes are collected, as provided by the Local Tax Collection Law of 1945, as amended and supplemented and the Local Tax Enabling Act.

Section 3. The tax collector shall give bond secured and conditioned for the collection and payment of such taxes as provided by Law for other Township Taxes.

Section 4. The entry of the occupation tax in the Tax duplicate and the issuance of such duplicate to the Tax Collector shall constitute his warrant for the collection of the occupation tax hereby levied and assessed.

Section 5. The expense of collection and compensation of the Tax Collector shall be paid and allowed as provided in the Local Tax Collection Law of 1945 as amended and supplemented which compensation shall be the same as shall be fixed from time to time for the collection of other Township Taxes.

Section 6. The Tax Collector shall give notice to the taxpayer of the amount of occupation tax due under this ordinance, at the same time and in the same manner as provided by the Local Tax Collection Law of 1945, as amended and supplemented.

Section 7. In case the Tax Collector shall at any time find within the Township any resident or inhabitant above the age of twenty-one (21) years, whose name does not appear upon the tax duplicate, he shall report the name of such person forthwith to the Assessor, who shall thereupon



certify the same unto the Township Supervisors which shall promptly certify the same for the Tax Collector reporting such name, whereupon the Tax Collector shall add such name and the assessment of this occupation tax against such person to the duplicate of the Township of Middletown, and shall proceed to collect the same.

Section 8. The Tax Collector shall give notice to the taxpayers, shall have the power to collect said taxes by distress, shall have the power and authority to demand and receive said tax from the employer of any person owing any occupation tax or whose wife owes any occupation tax, shall remit such taxes to the Township Treasurer by separate statement at the same time as other taxes are remitted to the Township, shall allow discounts and add penalties, shall generally be subject to all the duties and shall have all rights and authority conferred upon him by the Local Tax Collection Law of 1945, as amended and supplemented. It is hereby declared to be the intent of the Township Supervisors in enacting this ordinance to confer upon the Tax Collector, in the collection of this occupation tax, all the powers, together with all the duties and obligations to the same extent and as fully provided for in the Local Tax Collection Law of 1945, as amended and supplemented.

Section 9. This ordinance shall go into effect on the 15th day of January, 1993.

Section 10. If any sentence, clause or section or part of this ordinance is for any reason found to be unconstitutional, illegal or invalid, such unconstitutionality, illegality or invalidity shall not affect or impair any of the remaining provisions, sentences, clauses or sections or parts of this ordinance. It is hereby declared as the intent of the Township Supervisors that this ordinance would have been adopted had such unconstitutional, illegal, or invalid sentence, clause, section or part thereof not been included herein.
