Ordinance No. 452

AN ORDINANCE OF THE BOROUGH OF SUSQUEHANNA DEPOT, COUNTY OF SUSQUEHANNA IN THE COMMONWEALTH OF PENNSYLVANIA, PROMOTING THE GENERAL HEALTH, WELFARE, AND SAFETY OF THE BOROUGH OF SUSQUEHANNA DEPOT; PROVIDING FOR THE GREATER CONTROL AND MORE EFFECTIVE REGULATION OF EXCESSIVE SOUND AND NOISE, AND THE SOURCES OF EXCESSIVE SOUND WITHIN THE BOROUGH; AND ESTABLISHING PENALTIES FOR ANY PERSONS WHO FAIL, OR REFUSE, TO COMPLY WITH THE PROVISIONS OR REQUIREMENTS OF THIS ORDINANCE.

BE IT ENACTED AND ORDAINED by the Council for the Borough of Susquehanna Depot,
and it is hereby enacted and ordained by the authority of the same as follows:

Section 1. - SHORT TITLE

This Ordinance shall be known and may be cited as the "Susquehanna Depot Noise Control Ordinance."

Section 2. -INTENT AND PURPOSE

The intent and purpose of this Ordinance is to promote the general health, welfare, and safety of the Borough of Susquehanna Depot. Council finds that excessive levels of sound are detrimental to the physical, mental, and social well-being of the people as well as to their comfort, living conditions, general welfare and safety and being therefore a public health and welfare hazard, hereby declares it to be necessary to provide for the greater control and more effective regulation of excessive sound and the sources of excessive sound within the Borough.

Section 3. - DEFINITIONS

The following words, terms, and phrases when used in this Part shall have the meaning ascribed to them in this Section, except where the context clearly indicates a different meaning.


CONSTRUCTION OPERATION - the erection, repair, renovation, demolition or removal of any building or structure; and the excavation, filling, grading, and regulation of lots in connection therewith.

EMERGENCY - any occurrence or set of circumstances involving actual or imminent physical trauma or property damage.

THIS ORDINANCE SHALL TAKE EFFECT IMMEDIATELY UPON ITS PASSAGE AND APPROVAL.
