OF BRIDGEWATER TOWNSHIP

AUTHORIZING AND DIRECTING BRIDGEWATER TOWNSHIP MUNICIPAL AUTHORITY TO IMPOSE SEWER RENTALS FOR THE USE OF CERTAIN SEWERS; PROVIDING FOR PUBLIC NOTICE OF THE DATE SUCH SEWER RENTALS SHALL TAKE EFFECT AND THE SPECIFIC RATES; AUTHORIZING BRIDGEWATER TOWNSHIP MUNICIPAL AUTHORITY TO ADOPT RULES AND REGULATIONS GOVERNING THE USE OF CERTAIN SEWERS.

WHEREAS, Bridgewater Township did, on the 21st day of November 1980, transfer to Bridgewater Township Municipal Authority a certain sewage transportation system for a portion of Bridgewater Township; and

WHEREAS, Bridgewater Township desires to give to Bridgewater Township Municipal Authority the authority to impose sewer rentals and hook up fees for the use of certain sewers, more particularly described in a deed from Bridgewater Township to Bridgewater Township Municipal Authority dated November 21, 1980 and to impose sewer rentals and hook up fees for the use thereof and to adopt rules and regulations concerning the use thereof.

NOW THEREFORE, BE IT ENACTED AND ORDAINED AS FOLLOWS:

SECTION I. Each owner and user of any property served by the transportation system shall pay a sewer rental or service charge or hook up charge (in addition to any sewer rental or service charge now being paid to any other Municipal Authority), which is hereby imposed. Said sewer rental or service charge shall be payable quarterly in advance and shall be calculated from time to time by the Bridgewater Township Municipal Authority, unless and until different rates are established by ordinance by this municipality.

SECTION II. Bridgewater Township Municipal Authority shall give notice of the date of commencement of sewer rentals and hook up fees and of the initial schedule of such charges established by it, by publication at least one time in a newspaper of general circulation and shall provide a copy to Bridgewater Township, the governing body.

SECTION III. Bridgewater Township does hereby authorize Bridgewater Township Municipal Authority to adopt Rules and Regulations governing sewer rentals and sewer hook ups on the sewer line as hereinabove described.

SECTION IV. Any and all Rules and Regulations declared to the the Rules and Regulations of the aforesaid Authority shall be enforceable by the aforesaid Authority in accordance with the terms thereof.

SECTION V. The Rules and Regulations of Bridgewater Township Municipal Authority shall be subject to review by the governing body, Bridgewater Township, each and every 2 years from the date of this ordinance.

SECTION VI. All ordinances and parts of ordinances inconsistent with this ordinance and hereby repealed.

SECTION VII. This ordinance shall become effective Five (5) days after its adoption.
