

ORDINANCE NO. 6-6-11

AN ORDINANCE BY DIMOCK TOWNSHIP, SUSQUEHANNA COUNTY, PENNSYLVANIA, CHANGING THE NAME OF A PORTION OF A ROAD OR STREET REQUIRED FOR IMPLEMENTING THE ENHANCED 9-1-1 PUBLIC SAFETY SYSTEM PROGRAM, BEING PRESENTLY "DIMOCK TO BROOKLYN ROAD".

WHEREAS, Susquehanna County is implementing the Enhanced 9-1-1 Public Safety System Program which, when completed, will provide for improved emergency response that benefits the health, safety and welfare of all citizens of this municipality; and

WHEREAS, in order to implement this program, it is required that certain public roads or streets within the municipality be renamed to eliminate duplicate road names within the delineated 9-1-1 zones and to name and mark certain private roadways within the municipality; and

WHEREAS, a certain road in the Township, to wit: "Dimock to Brooklyn Road" a/k/a (SR 2024), has proved to bear a cumbersome, burdensome and inconvenient name for postal purposes.

NOW, THEREFORE, Be it Ordained and Enacted by the Board of Supervisors of Dimock Township, as follows:

**Section 1.** That the name of the existing public road known as "Dimock to Brooklyn Road" is hereby changed to "SR 2024" from its intersection with Route 29 in the Village of Dimock to its intersection with the Meshoppen Creek Road in Dimock Township, and that hereafter this section of road shall be identified and officially recognized by the name hereby given.

**Section 2.** That a sign or signs identifying the name of the road hereby identified or designated shall be placed, installed or posted as required for purposes of the Enhanced 9-1-1 Program.

**Section 3.** That a certified copy of this Ordinance shall be filed of record with the Clerk of Courts of Susquehanna County, Susquehanna County Emergency Management Agency, and the appropriate official of the Pennsylvania Department of Transportation for purposes of securing official documentation of the name hereby designated.


**Section 4.** That this Ordinance shall be effective immediately and shall remain in effect until modified by further Ordinance of the governing body.

**Section 5.** That all Ordinances or Resolutions and part of Ordinances or Resolutions inconsistent herewith are hereby repealed.
