

**ORDINANCE NO. 02-07-2013**

**An ordinance setting fines for parking violations within the Borough of Great Bend**

WHEREAS, The Borough of Great Bend has a police department; and

WHEREAS, The Borough of Great Bend is a political subdivision of The Commonwealth of Pennsylvania; and

WHEREAS, the motor vehicle code and the sections thereof, including but not limited to operation on and use of highways, parking on and off public roadways, activities permitted that employ use of public roadways and other uses of the roadways throughout the Borough whether they be state roads or Borough roads as set forth in the Consolidated Statutes of the Commonwealth of Pennsylvania are applicable to the jurisdictional boundaries of the Borough; and

WHEREAS, there is a need to ordain a set schedule of fines for violations of the vehicle code and the other applicable statutes of the Commonwealth.

THEREFORE, it is ordained that the following violations and fines for failure to adhere to the parking regulations shall be in effect within the Borough boundaries:

PARKED IN A PROHIBITED AREA .....	\$10.00
PARKED IN POSTED SNOW EMERGENCY ROUTE.....	\$10.00
PARKING/STANDING WITHIN 15' OF A FIRE HYDRANT.....	\$15.00
PARKING/STANDING ON SIDEWALK.....	\$15.00
PARKING/STANDING WITHIN 30' OF STOP SIGN.....	\$10.00
PARKING/STANDING IN FRONT OF PUBLIC/PRIVATE DRIVE.....	\$10.00
PARKING/STANDING-Prevents free Movement Streetcar(s).....	\$15.00
PARKING/STANDING OVER 12" FROM CURB OR SHOULDER.....	\$10.00
PARKING/STANDING WRONG WAY - TWO WAY HIGHWAY.....	\$10.00
PARKING/STANDING WRONG WAY - ONE WAY HIGHWAY.....	\$10.00
PARKED IN POSTED HANDICAPPED/DISABILITY PARKING.....	\$200.00
OTHER.....	\$_____

THAT these fines may be revised at future times by resolution of Great Bend Borough Council.

Payment shall be made within seventy two hours of the issuance of the ticket at the drop box outside the police station located at 335 Washington Street, Great Bend, PA. If not paid within seventy two hours the matter shall be referred to the District Court for action.

Violations of this ordinance shall subject the owner of the vehicle and the driver of the vehicle, if different individuals, to a fine of seventy five dollars (\$75.00), plus the appropriate cost for the violation as set forth above as well as all court costs imposed by the District Court should the matter proceed to a court action.
