

ORDINANCE NO: **483** OF **2011**

BOROUGH OF FOREST CITY

SUSQUEHANNA COUNTY, COMMONWEALTH OF PENNSYLVANIA

**AN ADMENDMENT TO THE ORDINANCES OF THE BOROUGH OF FOREST CITY, GENERALLY ORDINANCE 469, (WHICH AMENDED ORDINANCE 374) STREETS AND SIDEWALKS, PART 3B, "RESPONSIBILITY FOR REMOVAL OF SNOW AND ICE FROM SIDEWALKS", SPECIFICALLY SECTION 4, "PENALITY FOR VIOLATION".**

*WHEREAS*, the Forest City Borough is desirous of updating, modifying and revising Ordinance 469, (which had amended Ordinance 374-Streets and Sidewalks) which reads in pertinent part:

SECTION 4. Penalty for Violation. "Any owner, occupant or tenant of any property in the Borough of Forest City who shall fail to remove any snow or ice from any sidewalk as required by Part 3 B. Section of this ordinance shall be subject to a Twenty-five Dollar and no cents (\$25.00) a day fine, including costs, for each and every day that said violation continues unabated." Nothing in this section shall be read to replace any of the rights reserved to the Borough in Part 3 B., Section 2.

*WHEREAS*, the Borough of Forest City is desirous of changing the penalties incurred for violations of Section 4 and to make any future changes to the amount of penalties imposed subject to change by Resolution and not by formal amendment;

**BE IT ENACTED AND ORDAINED** by the Council of the Borough of Forest City that paragraph 3B, Section 4, Penalties for Violation shall be repealed and amended to read as follows:

SECTION 4. Penalty for Violation. Any owner, occupant or tenant of any property in the Borough of Forest City who shall fail to remove any snow or ice from any sidewalk as required by Part 3 B. Section 1 of this ordinance shall be subject to a Two Hundred Fifty

Dollar and no cents (\$250.00) a day fine, including costs, for each and every day that said violation continues unabated. Nothing in this section shall be read to replace any of the rights reserved to the Borough in Part 3 B., Section 2:


Any owner, occupant or tenant of any property in the Borough of Forest City who violates Part 3 B. Section 3 of this ordinance for prohibited use of rock salt shall be subject to a One Hundred Dollar and no cents (\$100.00) a day fine, including costs, for each and every day that said violation continues unabated. Nothing in this section shall be read to replace any of the rights reserved to the Borough in Part 3 B., Section 2.

Fines assessable for the violations of any provisions of this Ordinance and the codes may be established by the governing body by resolution from time to time without the necessity of formal amendment.
