ORDINANCE TO REESTABLISH MEMBERSHIP IN THE SUSQUEHANNA COUNTY COUNCIL OF GOVERNMENTS

AN ORDINANCE AUTHORIZING INTERGOVERNMENTAL COOPERATION BY CONFIRMING MEMBERSHIP IN THE SUSQUEHANNA COUNTY COUNCIL OF GOVERNMENTS, AND CONFIRMING THE CONDITIONS OF SAID MEMBERSHIP PURSUANT TO THE REQUIREMENTS OF PENNSYLVANIA CONSOLIDATED STATUTES, TITLE 53, SECTIONS 2301 THROUGH 2315, COMMONLY KNOWN AND REFERRED TO AS ACT 180, INTERGOVERNMENTAL COOPERATION LAW, AS AMENDED, OF THE COMMONWEALTH OF PENNSYLVANIA.

WHEREAS, Pennsylvania Consolidated Statutes- Title 53, Sections 2301 through 2315, commonly known and referred to as Act 180, Intergovernmental Cooperation Law, is the law governing intergovernmental cooperation within the Commonwealth of Pennsylvania; and

WHEREAS, each of the member municipalities have agreed to cooperate with the other governmental or quasi-governmental units in the execution of those municipal functions deemed by the member municipalities to be accomplished best through cooperation with the other governments or quasi-governmental units; and

WHEREAS, the intergovernmental Cooperation Law of the Commonwealth of Pennsylvania intends that full recognition by the commonwealth of Pennsylvania or an, agent of intergovernmental cooperation requires said agent to be established by Ordinance by all cooperating units of government; and

WHEREAS, the member municipalities desire the Susquehanna County Council of Governments to be as useful as possible to those municipalities, and the residents thereof.

NOW, THEREFORE, the Supervisors of Oakland Township, Susquehanna County, Pennsylvania, do hereby ordain the following:

MEMBERSHIP:

That Oakland Township of Susquehanna County, Pennsylvania joins and will be a member of the Susquehanna County Council of Governments in accordance with the By Laws of the Susquehanna County Council of Governments, and any laws, agreements or contracts which apply.

BY-LAWS:

That the By-Laws of the Susquehanna County Council of Governments attached hereto and made a part hereof are hereby approved, and that such By-Laws may be amended

from time to time by a voting representation of member municipalities of the
Susquehanna County Council of Governments.

SEVERABILITY:

If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any Court of competent jurisdiction, such portion shall be deemed a separate distinct and independent provision and holding shall not affect the validity of the remaining portions of this ordinance
