

GREAT BEND BOROUGH ORDINANCE #11-07-24

AN ORDINANCE RESTRICTING PARKING ON THE SOUTHERN SIDE OF WATER STREET FROM FRANKLIN STREET TO MAIN STREET (US ROUTE 11).

WHEREAS, the Borough Council of the Borough of Great Bend, Susquehanna County, Pennsylvania has, pursuant to 53 PS §46006(3), the power to enact certain ordinances as it shall deem beneficial to the Borough; and

WHEREAS, it is deemed beneficial to prohibit parking at certain locations throughout the Borough of Great Bend; and

WHEREAS, a hazard has been deemed to exist on Water Street in the Borough of Great Bend in that fire and emergency vehicles have difficulty navigating the street when vehicles are parked on both sides; and

WHEREAS, the Council has determined the hazard can be reduced by the enactment of an ordinance relating to parking on said street; and

WHEREAS, the Ordinance would be beneficial to the Borough of Great Bend and its citizens,

NOW, THEREFORE, the Council of the Borough of Great Bend, Susquehanna County, Pennsylvania, does hereby ordain and enact the following Ordinance:

In addition to the statutory "No Parking," as stated in the Code of the Commonwealth of Pennsylvania, the Borough enacts additional restrictions on parking in that:

No person or persons shall park a vehicle or allow a vehicle to remain parked, at any time, on the southern side of Water Street from its meeting point with Franklin St. to US Route 11 (Main St.).

The Borough of Great Bend Council further authorizes the appropriate police authorities, whether they are State, local, or contracted, to enforce this Ordinance.

Each parking occurrence longer than five minutes in length shall be deemed a separate violation.

ANY PERSON(S) who violates any provision of this Ordinance shall, upon conviction, be sentenced to pay a fine of not more than Seventy-Five Dollars (\$75.00), plus the costs of prosecution and such other and further penalties as the laws of the Commonwealth allow.
